2024 BUDGET & TAXES

New for 2024 is the implementation of a special tax for Emergency Medical Services (EMS), which is further explained later in this newsletter. Also new for 2024 is the abolishment of the per capita tax.

The general purpose real estate tax remains unchanged from 2023, as does the fire protection tax, and the water hydrant special assessment.

The total budget (combined revenue & expenditures) for 2024 is \$7.74 million dollars.

OPPORTUNITY FOR COMMUNITY INPUT

SOUTHERN YORK COUNTY REGIONAL COMPREHENSIVE PLAN

The Southern York County Regional Planning Commission (SYCRPC) is currently working on an implementable, action-oriented 10-year Comprehensive Plan update for the Boroughs of Glen Rock, Railroad, New Freedom, Shrewsbury, and the Township of Shrewsbury. The plan will cover a range of topics, including community goals and objectives, future land-use maps, and implementation strategies.

A comprehensive plan is a long-range plan that captures the vision of where the community wants to be at some point in the future. It is an ordered process that determines community goals and aspirations in terms of community development. This resulting document expresses and regulates public policies on transportation, utilities, land use, recreation, and housing. Comprehensive plans typically encompass large geographical areas, and a broad range of topics, and cover a long-term time horizon.

The SYCRPC is seeking community input to ensure that the plan reflects the needs and aspirations of the residents of the Southern York County Region. To this end, the commission will launch online community surveys to gather feedback from the public. The survey is available on the Shrewsbury Township website.



HOUSEHOLD WASTE COLLECTION EVENT

3.57 TONS OF MEDICATION DESTROYED IN 2023

In 2023, the York County Solid Waste Authority (YCSWA) disposed of a total of 3.57 tons of unused and expired residential medication collected via the YCSWA's secure Medication Return Box Program.

Currently, 20 York County police department locations partner with the YCSWA to host Medication Return Boxes in their police department lobbies, including the Southern Regional Police Department, 47 E. High Street, New Freedom, PA 17349. Unused and expired medications can be dropped off anonymously in the police department's lobby, Monday through Friday, from 8:00 AM to 4:00 PM.

Residents should remove their personal information from containers before



depositing them in the box.
ONLY RESIDENTIAL prescription medications are accepted, as well as pet medications.

UNDERSTANDING YOUR PROPERTY TAX BILLS

The Township Office and the Tax Collector frequently receive questions about tax bills. What is this tax bill for, who receives the taxes, why do I receive two (2) tax bills each year, etc. Hopefully, the following brief explanation of each tax bill will help answer those questions.

FEBRUARY (Municipal) Tax Bill (Calendar Year)

The tax bill that is mailed in February of each year includes both the York County and the Shrewsbury Township taxes/assessments on one (1) bill. The breakdown is as follows, <u>based upon</u> a property <u>assessed value</u> of \$200,000:

- York County (Real Estate Tax) revenue from this tax is used for the general operation of the County. The tax rate is set by the York County Commissioners.
- ² **Township (Real Estate Tax)** revenue generated from this real estate tax is used for general operations of the Township [i.e. roads, stormwater, recreation, parks, personnel, administration, legal, engineering, insurances, equipment, building & equipment maintenance, utilities, planning & zoning, debt service, and community organization donations (libraries, senior center, rail trail, etc.)]. Current tax rate has not changed since 2008, which is set by the Shrewsbury Township Board of Supervisors.
- EMS Tax this is a new tax beginning in 2024, which was implemented to provide additional support to the two (2) ambulance services that serve the Township; specifically, Rose (New Freedom) EMS and Glen Rock Ambulance. The decline in volunteers and reduction in Medicare/Medicaid reimbursement, has resulted in the need to rely on more paid staff. This tax can be used ONLY for EMS; it cannot be used for any other purpose. The tax rate is set by the Shrewsbury Township Board of Supervisors.
- ⁴ Fire Tax this tax has been in place since 2008. It provides financial support to the three (3) "all volunteer" fire companies that serve Shrewsbury Township, which includes Glen Rock Hose & Ladder, Rose (New Freedom) Fire Company, and Shrewsbury Volunteer Fire Company. The revenue collected by this tax can be used ONLY to support the volunteer fire companies. The tax rate is set by the Shrewsbury Township Board of Supervisors.
- Hydrant Assessment this is a special assessment on any property that is located within 780 feet (maximum distance set by state law) of a fire hydrant owned by The York Water Company or Glen Rock Water Authority. The Township is billed annually for the rental of each fire hydrant. Shrewsbury Borough does not bill for their fire hydrants. The revenue collected from this special assessment is also restricted to expenses related to the fire hydrant rental charges. The assessment rate is set by the Shrewsbury Township Board of Supervisors.

JULY (School) Tax Bill (Fiscal Year July 1 – June 30)

This tax bill is mailed in July of each year and is for the Southern York County School District (Susquehannock). The tax rate is set by the Southern York County School Board. The breakdown is as follows, <u>based upon</u> a property <u>assessed value</u> of \$200,000:

ANNUAL TAX SUMMARY

In summary, if your property is assessed at \$200,000, your TOTAL TAXES are \$5,554, and of that amount, the amounts paid to each of three agencies is as follows:

ABOLISHED - TOWNSHIP PER CAPITA TAX

The \$5.00 per capita tax (often referred to as a "nuisance tax") assessed on every resident aged 18 or older has been abolished by the Board of Supervisors, effective January 1, 2024. You will no longer receive that tax bill with your County/Township tax bill.

ENACTED - EMERGENCY MEDICAL SERVICES (EMS) TAX

As most are aware, volunteerism across the country and in every organization/service continues to rapidly decline. This trend is very evident in the volunteer ambulance services, with local ambulance services turning to partial or fully paid staff. The combination of the need for paid Emergency Medical Technicians (EMTs), significant reductions in Medicare/Medicaid payments for EMS services, and rising operating costs, has lead to the need for greater financial support from the communities in which the ambulance companies serve.



The time has arrived that the Township had to enact a special tax strictly for the purpose of provided emergency medical services to the residents. All revenue collected from this tax can be used only for EMS. This new tax will appear on the County/Township tax bill that you received in February. A home assessed at \$200,000 will pay \$66.00 in 2024 for EMS.

TAX COLLECTOR

The Shrewsbury Township tax collector is elected to a four (4) year term, who is responsible for collecting the above taxes from Shrewsbury Township property owners on behalf of the Township, York County, and the Southern York County School District, each of whom set their own tax rates.



ROAD IMPROVEMENTS

Asphalt Paving Vs Calibrated Chipping

A common question asked during the paving season is why the Township uses calibrated chipping (often referred to as "tar & chip")

instead of the traditional asphalt (blacktop) paving.

Both methods provide a durable and long lasting road surface, but calibrated chipping is more economical than asphalt paving.

For example, a road that is one (1) mile long & 18 feet wide (10,560 sq. yd.):

- ♦ \$80,400 Asphalt (9.5 MM at 2" depth)
- ♦ \$34,240 Calibrated Chipping (double application)
- \$46,174 Cost savings per road (using calibrated chipping)

There are several factors in determining the resurfacing application, such as condition of the existing roadway, daily traffic volume, and location (rural, residential, high density housing, low density housing, etc.).

JUST IN TIME FOR ST. PATTY'S DAY

Could you have some luck of the Irish? The Pennsylvania Treasury Department encourages everyone to check if you might have a piece of their \$4.5 billion worth of unclaimed property.

Unclaimed property is turned over the PA Treasury Department for dormant bank accounts, uncashed checks, insurance policies, stocks, etc. The average claim amount is \$1,600.

NUMBER OF PRESERVED FARMS GROWS IN TOWNSHIP

The York County Agricultural Land Preservation Board recently approved the addition of 128 acres of preserved land in Shrewsbury Township, which increased the total of preserved agricultural land in the Township to 3,230 acres.

When land is preserved under the program, a deed of agricultural conservation easement has been executed, and the restrictions placed on the land limits the use to commercial agricultural preservation in perpetuity (forever).

2023 PA PROPERTY TAX/RENT REBATE PROGRAM

Older adults and people with disabilities 18 and older in Pennsylvania may be eligible to receive up to \$1,000 in rebates. The Property Tax/Rent Rebate Program supports homeowners and renters across Pennsylvania by providing a rebate ranging from \$380 to \$1,000 to eligible older adults and people with disabilities age 18 and older. The program is supported by funds from the Pennsylvania Lottery and Gaming.

Homeowners and renters in Pennsylvania may be eligible to receive up to \$1,000 through a standard rebate. The amount of money you will receive is based on your income. Some applicants may qualify for supplemental rebates as well.

Income	Maximum Rebate
\$0 - \$8,000	\$1,000
\$8,001 - \$15,000	\$770
\$15,001 - \$18,000	\$460
\$18,001 - \$45,000	\$380

This program supports Pennsylvania homeowners and renters who are 65 and older, widows or widowers 50 and older, or people with disabilities 18 and older. In addition to age requirements, your household income must be \$45,000 or less annually.

Applications are due by June 30, 2024.
